The Foundation's management board has one member i.e. the management board president: Katarzyna Kulik, residing in 42-470 Siewierz, ul. Zbożowa 83.

4) Statutory objectives of Our Children Foundation:

The objective of the Foundation is to run the following types of activity for the community:

- education of children and youth,
- activity related to family, motherhood, parenting, promoting and protecting children rights,
- promoting and supporting physical culture among children and youth,
- charity for children, youth and families experiencing life difficulties,
- activities aimed at promoting art and culture, national heritage protection among children and

youth, especially those in a difficult financial situation,

- protection and promotion of health among children and youth, especially those experiencing life difficulties,
- social aid, including support for families and persons experiencing life difficulties, and creating equal opportunities for those families or persons,
- promotion of tourism among children and youth, especially those experiencing life difficulties,



- promoting and organizing volunteer activities,
- activity aimed at European integration and developing contacts and co-operation between societies.
- supporting and promoting national tradition, cultivating patriotism and raising national, civil and cultural awareness in children and youth,
- organizing leisure activities for children and youth, especially those experiencing life difficulties,
- promoting ecology, protection of animals and natural heritage.

To achieve its objectives the Foundation may support activity run by other people and institutions which corresponds to its objectives.

5) Rules, forms and scope of activity defined in the Foundation's Statute:

The main project run by Our Children Foundation in 2011 was the project covering the area of children education (§ 6 item 1 of the Foundation's Statute), and activities related to family, motherhood and parenting (§ 6 item 2 of the Foundation's Statute), and included co-organization and financing ArcelorMittal Poland Private Kindergarten "Równe Przedszkolaki" in Dąbrowa Górnicza, both at the investment stage and actual running of the kindergarten.

The kindergarten was registered in the record maintained by the President of Dąbrowa Górnicza on August 9, 2011 under number: WO.4430.3.1.2011.

Education services provided by the kindergarten are documented by monthly Preschool Report Cards prepared individually for each group. Almost all objectives of the Foundation are achieved through activities organized in the kindergarten, in particular: educational activity, promotion of physical culture, art and culture, protection and promotion of children's health, promotion of tourism, cultivating Polish national traditions, and promotion of ecology.

Results of activities performed under the project of the Company's kindergarten:

- Introduction of an investment-oriented attitude towards the management of social fund resources instead of consumption-oriented one.
- Kindergarten provides care for 100 children aged 2.5 6, there is a possibility to extend the kindergarten and provide care for 150 children.
- Educational program followed in the kindergarten, highly-qualified teachers and optimum amount of toys and teaching aids, as well as technical, sport and leisure infrastructure allow children to develop, and this growth is clearly visible to their parents.
- Parents' satisfaction from educational services provided by the kindergarten a.o. daily English classes, at almost 100%.
- The kindergarten also accepts children who could not attend other kindergartens because of their health condition and provides them with professional care (protection of children's health § 6 item 2 of the Foundation's Statute),
- Parents have bigger opportunities on the job market kindergarten is open from 5:30 a.m. to 6 p.m. Monday to Friday all year round, also during summer and winter holidays, except for statutory days off.



- Promoting corporate social responsibility ideas, employee voluntary service and social work in the areas of parenting, motherhood, health and education of children and youth.
- 8. Setting a high standard for other local private and public kindergartens.
- 9. A long-term investment for several generations.
- 10. Poland is more attractive as a place to live and work, educate children, especially for young and qualified engineers and graduates of other technical schools.

The project was run by the Foundation but it was eagerly supported by many volunteers (§ 6 item 9 of the Foundation's Statute), - mostly ArcelorMittal Poland employees.

Kindergarten project run by the Foundation involved:

- developing, verifying and gaining approval for the idea regarding the functioning and financing of the kindergarten in Dąbrowa Górnicza;
- cooperating in scope of financial means collection ensuring that the kindergarten is equipped with appropriate toys, playgrounds, furniture, educational resources and technical equipment;
- developing, verifying and gaining approval, conclusion of the agreement on 22.07.2011 as well as the execution of the provisions thereof in scope of educational services in the kindergarten, including cooperation in settling formalities related to registration of the kindergarten in the education system, contract settlement (four settlements for the period from September to December 2011), conducting ongoing control of the kindergarten activity and submitting files for additional equipment or upgrade of technical and functional aspects of the kindergarten building, making decisions regarding amendments to the kindergarten statute and agreements with parents;
- initiating and organizing meetings as regards the functional and technical service of the kindergarten (four meetings, the course of which is recorded in the minutes);
- participating in the inspection of buildings and the premises of the kindergarten aimed at ensuring compliance with health and safety requirements (1 inspection);
- developing and running a survey aimed at determining parents' satisfaction in relation to educational services provided in the kindergarten (almost 100% satisfaction);
- conducting interventions at parents' request;
- developing and verifying enrollment rules for the school year 2011/2012, setting up six-member admission committee (12 meetings of the enrollment committee in the period from February to December 2011, number of children in the kindergarten as on December 31, 2011 - 39);
- developing and verifying enrollment rules for the school year 2011/2012, setting up six-member enrollment committee responsible for enrolling children in the kindergarten in Dąbrowa Górnicza for the school year 2012/2013;
- preparing a request to repair lights along the road leading to the kindergarten (at present, technical documentation is being prepared, repair is planned for 2013) and filing it with the City Administration Office;
- winning sponsors who will provide funds necessary to purchase professional portable audio amplifiers;



- organizing a family event in the kindergarten for both children and their parents "Bonfire cookout" together with organizing sports and leisure activities, participation of the Foundation's volunteers (5 volunteers);
- the Foundation's volunteers assisted children and their parents in preparing Christmas decorations, cards as well as decorating the kindergarten for Christmas (6 volunteers);
- winning funds for technical design and launch of the website <u>www.fundacja-naszedzieci.pl</u> for the Foundation and kindergartens in Dąbrowa Górnicza and Kraków. Our Children Foundation has developed a website map and necessary functionalities. It is also responsible for administering and updating the content of the website on an ongoing basis, writing texts and designing graphics for the website;

In 2011, in view of the plans to open ArcelorMittal kindergarten in Kraków on September 1, 2012, Our Children Foundation designed a survey to measure the level of interest in this initiative among the employees of ArcelorMittal Poland Unit in Kraków. In addition to this, it obtained approval for the developed and verified concept of functioning and financing the kindergarten in Kraków.

Apart from the statutory activity, in 2011 the Foundation also conducted activities related to the Foundation's organization, including:

- finding a company rendering accounting services for the Foundation free of charge, negotiations and conclusion of the contract;
- updating NIP, KRS, Regon documentation;
- opening a bank account for the Foundation;
- winning, servicing and settling donations used for financing everyday activities of the kindergarten and the Foundation (in 2011 the Foundation concluded three donation agreements);
- developing, reaching agreements and approving the budget for 2012;
- development and documentation-related arrangements, winning funds and gaining consent to employ two employees as of January 1, 2012;
